HOW TO ENTER

Consumers must purchase, between the 1st October, 2008 and 31st December, 2008, a new Ricoh digital camera, specifically one, or more, of the models R8, R10, GX200, GRD AND G600 from the current 2008 range, from any participating retailer. They must then complete the entry form, provided by the retailer, and mail the completed form to Tasco Sales (Aust) Pty Ltd, PO Box 221, Brookvale NSW 2100. Only one entry is permitted per product purchased.

CONDITIONS OF ENTRY

1. Information on how to enter and prizes form part of these conditions of entry.
2. Entry is open only to Australian residents. Employees and immediate families of the promoter, participating outlets and their agencies associated with this promotion are ineligible to enter.
3. The promoter reserves the right to verify the validity of entries and to disqualify any entrant who tampers with the entry process or who submits an entry that is not in accordance with the terms and conditions of entry.
4. Only one entry is permitted per product purchased.
5. The promotion commences on the 1st October, 2008. The promotion ends at 5:00pm AESDT on 31st December, 2008. Entries must be received by Tasco Sales (Aust) Pty Ltd, no later than Friday the 16th January, 2009. The draw will take place at Unit 6 Winbourne Estate, 9-13 Winbourne Road, Brookvale NSW on Friday the 23rd January, 2009 at 10:00am AESDT. Winners will be notified by mail and their names will be published in *The Australian* newspaper of Wednesday the 28th January, 2009. The judge's decision is final and no correspondence will be entered into.

The first valid entry drawn will win the prize, comprising a trip for two adults to Hong Kong, valued at up to \$7200, depending upon the point of departure, including return economy airfares, from the winners nearest capital city, on dates to coincide with the Hong Kong Sevens rugby football competition in 2009. Flying out from Australia on the 26th March, 2009 and flying out of Hong Kong on 30th March, 2009 returning to Australia. The prize includes four nights accommodation at a four star luxury hotel, breakfast, transfers to the football grounds, football tickets and transfers to and from Sydney and Hong Kong international airports.
